WHEREAS, on April 30,1997, Developer executed that certain Declaration of Easements, Covenants, Conditions and restrictions and Homes Association for Southwood Subdivision (the "Declaration") which encumbers the real property situated in Overland Park, Johnson County, Kansas, as legally described on Exhibit "A" attached hereto and incorporated herein by this reference (the "Property"). 1. <u>Amendment</u>. Article XIII of the Declaration is hereby amended by adding the following to the end thereof:

"Notwithstanding the foregoing, Developer, its successors, assigns, employees, agents and subcontractors are and shall be bound by all of the terms, covenants, conditions and restrictions of this Declaration with regard to any and all acts relating to any of the Lots or any part of the Community, and Developer, its successors, assigns, employees, agents and subcontractors shall abide by all of the terms, covenants, conditions and restrictions hereof."

2. <u>Declaration</u>. Except as amended hereby, the Declaration shall remain in full force and effect in accordance with the terms thereof. Any capitalized terms not defined herein shall have the same meaning as defined in the Declaration
